CALL FOR PAPERS

The scope of issues to be discussed at the conference covers the present EU-Russia relations and their interaction in Eurasia, primarily in the post-Soviet space. The following research areas are suggested for discussion:

- Historical aspects of the relations between Russia and European countries;
- History of the interactions between the EU and the Russian Federation;
- The present EU-Russian relations;
- Russia and the EU in the post-Soviet space;
- Russia and the EU in Eastern Europe: challenges and controversies;
- Russia and the EU in the Middle East

The programme committee welcomes papers submitted for discussion by colleagues from Russian and foreign universities and young researchers (undergraduate and postgraduate students) majoring in History, International Relations, Political Science, International Law, etc.

Apart from the conference sessions, the conference program will include 4 seminars for young researchers:

1. “People’s diplomacy” mechanisms in the Russia-EU interaction
2. Demographic Development of Europe and the Neighbouring Regions
3. The Russia – Germany Interaction: 1992 - present
4. Russia-EU Cooperation in the Sphere of International Security

The conference proceedings will be indexed in the Russian Science Citation Index. Selected papers will be published in international reviewed journals and indexed in Scopus/Web of Science.

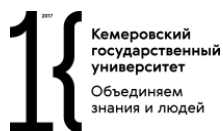

Paper Submission Guidelines

Paper structure:

1. Universal Decimal Classification ([UDC](#)) index.
2. Title.
3. Name(s) of the author(s).
4. Abstract.
5. Keywords.
6. Body of the papers with tables and figures.
7. References.
8. Information about the author(s): full name; academic degree and title; affiliation and position; telephone number and/or email; profile link in ORCID.

Guidelines for paper formatting:

1. The paper should be submitted as a .doc .docx or .rtf file, with indentations but no paging or special preformatting settings.
2. The recommended size for a research paper is 20 000 characters, including abstract, keywords, footnotes and references.
3. **The title** (max. 10-12 words) should reflect the subject, topic, and objective of the research.
4. **The short information about the author(s)** should include their names and affiliations.
5. **The abstract** (150–250 words) should be informative, original, well-structured and compact. It should reflect the object of the research; the research tasks, objectives and methods; the research results and the scope of their application, and conclusion.
6. The recommended number of **keywords** is 6–10.
7. **The body of the paper** should include the following sections: Introduction; Methods and Materials; Results; Conclusions.
8. The figures made in MS Office should be enclosed as separate .xls or .vsd files
9. The scanned images and photographs should be enclosed as separate .tif, .jpg, or .png files with a resolution of 300 dpi;
10. Tables should be enclosed as editable text, not images.
11. **References** should only include the sources and literature used when preparing the paper. In-text references should be given in [square brackets]. The recommended number of references is 25–40.
12. The list of references should be placed after the text. References should be listed and numbered in the order of their appearance in the paper, one source per number.
13. Any sources can be cited. Yet, references to unpublished works, state documents (decrees, laws, etc.), historical documents, newspaper articles, Internet sources without authorship (forums, blogs, etc.) should be given as footnotes.
14. Dictionaries, fiction books, op-ed articles and other sources should be included in a separate list of references.
15. In case of referencing to Internet sources, the rules for describing online electronic publications should be observed.
16. Self-citation should not exceed 10% of the references.
17. Reference lists should be formatted according to Chicago-style citation.
18. The last page of the submission should include the full information about the author(s): full name; academic degree and title; affiliation and position; telephone number and/or email.
